Code of Ethics

## 1. INTRODUCTION

The Code is an ethical guide for day-to-day, interactions and decision-making for those who conduct the business and the affairs of the Fraser Valley Feline Welfare Society. The Code of Ethics reflects the core values of the Fraser Valley Feline Welfare Society's incorporation.

The provisions of this Code are intended to complement and enhance in a consistent manner, the requirements that arise at law and in the by-laws of the Fraser Valley Feline Welfare Society.

The Code of Ethics replaces the *Director's Code of Conduct and Policy of Conflict of Interest* document.

# 2. SCOPE

The Code of Ethics applies to employees, volunteers (including the Board of Directors), voting members and network partners.

## 3. VALUES

The Code of Ethics is guided by the following values:

We believe in **HONESTY**, therefore we will be transparent and accountable to our donors and the communities we serve.

We believe in **LEADERSHIP**, therefore we will use promising and best practices to be agents of change in animal welfare.

We believe in **COMMUNITY MINDEDNESS**, therefore we will foster an environment of trust and collaboration by nurturing relationships.

We believe in **COMPASSION**, therefore we will exhibit empathy and kindness towards people and animals.

We believe in ADVOCACY, therefore we will commit to speaking on behalf of all companion animals and promote the human-animal bond.

## 4. PRACTICAL GUIDELINES

#### 4.1 ETHICAL BEHAVIOUR TOWARD ANIMALS

We will act at all times in accordance with the *Prevention of Cruelty to Animals Act* and the Five Freedoms.

### 4.2 INTERNAL AND EXTERNAL RELATIONS

We will treat each other with respect and dignity.

We will be independent and partial, and not be influenced by self-interest, outside pressure, expectation of reward or fear of criticism.

We will act with honesty and integrity and conduct ourselves in a manner consistent with the nature and responsibilities and the maintenance of public confidence in the conduct of business.

Know and respect our individual roles within the organization.

#### 4.3 CONFLICT OF INTEREST

These Conflict of Interest Guidelines are intended to ensure the highest standards and maintenance of the integrity of all individuals acting on behalf of the Fraser Valley Feline Welfare Society.

We shall act at all times in the best interests of the Fraser Valley Feline Welfare Society rather in the interests of particular constituencies. This means putting the interests of the Fraser Valley Feline Welfare Society ahead of any personal interests or interests of any other person or entity.

A conflict of interest refers to situations in which personal occupational or financial considerations may affect or appear to affect, or objectively, judgment or ability to act in the best interest of the Fraser Valley Feline Welfare Society.

A conflict of interest may be real, potential, or perceived in nature.

Full disclosure, in itself, does not remove a conflict of interest.

#### 4.4 ACCOUNTABILITY

We will be accountable for the decisions we make and the actions we take. We will be responsible stewards of the Fraser Valley Feline Welfare Society assets, including ensuring the appropriate use of funds and accountability in donors.

## 4.5 COMMUNICATION AND CONFIDENTIALITY

We will be effective representatives in all of our communications to ensure that the Fraser Valley Feline Welfare Society presents and maintains a positive public image. We will speak on behalf of the Fraser Valley Feline Welfare Society only if we have the authority to do so.

We will respect the principle of confidentiality.
